

Spring 2014 Summary of Code of Student Conduct Violations and Sanctions

One Point:

- Four students of legal drinking age received one point each for possession of alcohol in a public place
- One student received one point after being arrested in the Village of Clinton for public urination.
- Three students received one point each for smoking cigarettes inside a residence hall.
- One student received one point for being disruptive on the late night jitney

Two points:

- Three students received two points each for possession of a false form of identification
- Four students received two points each for possession of alcohol under the age of 21
- Seven students received two points each for unauthorized access to a college facility
- One student received two points for a noise policy violation
- A student received two points after they were confronted by Campus Safety for rolling a keg of beer down College Hill road
- Two students received two points each for a second violation of the College's smoking policy
- Four students received two points each for possession of drug paraphernalia

Three points:

- One student received three points for disruptive behavior and failing to comply with a Campus Safety officer
- Seven students received three points each for attempting to use a false form of identification
- Four students received three points each for possession of alcohol under the age of 21 and failing to comply with a directive from Campus Safety
- Three students received three points each after being arrested in the Village of Clinton for attempting to use a false form of identification when purchasing alcohol
- Two students received three points each for urinating in public
- One student received three points for rolling a keg of beer down College Hill road then attempting to run from Campus Safety
- Seven students received three points each for possession/use of marijuana outside of a residence hall
- Two students received three points each for disruptive behavior on the late night Jitney
- Four students received three points each for possession of Hamilton College property in their residence hall room

Four Points:

- Two students received four points each for providing alcohol to students under the age of 21
- Eight students received four points each for violation of the College's smoking policy and use of marijuana in a residence hall
- Four students who turned themselves in to Campus Safety or their RA received four points each and paid double the cost of repair for damage they caused to college or personal property
- A student received four points for expelling the contents of a fire extinguisher when no fire existed
- Four students received four points each for unauthorized access to a construction site
- One student received four points for streaking on campus

Five Points:

- One student received five points for possession of marijuana and multiple pieces of paraphernalia

Six points:

- One student received six points for threatening and intimidating behavior toward a RA
- One student received six points for violation of College's smoking policy, use of marijuana in a residence hall and failure to comply with a directive from Campus Safety
- One student received six points for consumption of alcohol on the late night Jitney, being disruptive on the Jitney and failure to comply with a directive from Campus Safety
- One student received six points for covering the smoke detector in their residence hall room
- One student received six points for unauthorized access to a College facility, attempting to use of false identification and failure to comply with a directive from Campus Safety

10 Points:

- One student who was arrested in the Village of Clinton for engaging in a physical altercation was assigned ten points and suspended for one semester
- One student who put other student's safety at risk by causing significant damage to a residence hall and who engaged in physical altercation with their roommate was assigned ten points and suspended for two semesters.

Other sanctions:

- A graduating senior who stole property from another student had their degree withheld for one year

- A graduating senior who caused damage to a residence hall during senior week was removed from campus for the remainder of Senior Week and only allowed to return for commencement
- Two students each had their ability to function as a social hosts revoked for policy violations at an event they were hosting
