However, no fire alarm, detection or suppression system can 100% guarantee that a tragedy will not occur. While there are a number of College departments charged with administering Hamilton's fire safety programs, all students and employees must DO THEIR PART and abide by this Fire Safety Notice.

### SMOKING AND VAPING

By college policy and the NYS Clean Indoor Act, smoking of any kind and vaping is PROHIBITED in all College buildings, entranceways, and College-owned vehicles.

Additionally, smokers/vapers must stay at least 25 feet away from all buildings while smoking to protect non-smokers from unwanted exposure to environmental tobacco smoke.





Fire Safety NEVER TAMPER WITH OR OBSTRUCT FIRE SAFETY EQUIPMENT INSTALLED IN YOUR BUILDING SUCH AS:

- Sprinkler heads/piping
- Smoke/heat detectors
- Fire extinguishers
- Fire/smoke doors
- Fire alarm panels
- Pull stations
- Exit/egress signage

# **STORAGE ISSUES**

The storage of personal property (shoes, laundry, athletic equipment, bikes) is NOT permitted outside of your assigned space. Storing such items in hallways or other emergency egress corridors is a fire safety violation.

Removing college-owned items from your space and storing them in hallways or other emergency egress spaces is a fire safety violation.

### **BEST PRACTICES**

#### **POWER STRIPS:**

- Use a power strip that will shut off automatically in the event of a power surge
- Never plug multiple devices into each other, nor plug one power strip into another.

#### FOOD STORAGE/COOKING/PREP

Employees should utilize designated kitchenettes.

- For energy conservation purposes, employees are discouraged from having personal refrigerators in their offices.
- The only permissible food warming devices outside of kitchenettes include those with internal/self-contained coils.

#### FIRE EXTINGUISHERS:

- These devices are on hand throughout campus
- If you would like to be trained to use one, please contact Environmental Protection, Safety, & Sustainability

#### SPRINKLERS:

- Never hang anything from your sprinkler
- Never position any items within 18 inches of your sprinkler

# **PROHIBITED ITEMS**

- Light-duty household extension (or zip) cords
- Multi-plug adapters
- Plug-in string lights
- Lava lamps
- Heat lamps
- Candles/Incense
- Electric blankets
- Space heaters\*
- Air conditioners\*
- Live Christmas trees
- \*unless provided by FM

## **CORRECTIVE ACTIONS**

All college facilities, including employee offices, are subject to regular inspection by the office of Env. Protection & Safety, Campus Safety, Facilities Management and the NYS Office of Fire Prevention & Control (OFPC). Depending on the nature and severity of any fire safety related violations discovered during an inspection, corrective actions may be levied upon the responsible party(ies), including but not limited to, additional instruction, onthe-spot confiscation or disciplinary action.
